Any inspections required after normal work hours, including Saturday & Sunday, require a \$100.00 fee in addition to required permit.

In addition to the fees for building permits provided in Section 1329.03, the following fees shall be collected by the Building Commissioner for electrical work:

(a) For an **Electrical Contractor's License** for a maximum of one year, expiring on December 31st of the year (the licensee to hold a State of Ohio Electrical Contractors license).....**\$50.00**
