Mrs. Carmen stated that the pool still needs to be heated and treated.

Mayor Gorden stated that he would like the pool schedule to remain the same as last year.

Mr. Eisen stated that he would like to see the actual costs. Mr. Eisen asked if anyone has been laid off.

Mr. Jacobs stated more layoffs will mean more overtime.

Mr. Eisen requested a breakdown on pass and daily fee charges.

Mrs. Carmen stated that people who work in Beachwood are allowed to use the pool for a \$100.00 charge without bringing their families.

The Committee suggested raising the individual rate by \$5.00, family rate by \$10.00, and \$155.00 for a family of four and an additional \$20.00 for more than four.

The Committee stated that programs will be cancelled if the costs are not covered by attendance.
