In addition to the fees for building permits provided in Section 1329.03, the following fees shall be collected by the Building Commissioner for heating work:

- (a) For an **Air Conditioning and Heating Contractor's License**, for a maximum of one year, expiring on December 31st of the year; the licensee to hold a State of Ohio HVAC license.....**\$50.00**
- (b) Furnace/AC contractor must schedule an inspection within 72 hours or an administrative fee will be charged of.....**\$100.00**
