P&Z 2024-8 James Kassay, ADA Architects Inc, is requesting preliminary and final site plan approval for a new fenced playground area to be located at 23825 Commerce Park, Primrose School of Beachwood.

Mr. James Kassay stated Primrose School is proposing to use the first floor of the existing two-story office building. He reviewed the site and building layout.

Mr. Roenigk stated the Police and Fire Departments had no comments. The Building Department has concerns about the fencing that abuts the existing parking lot and may request installation of bollards.

Mr. Kassay replied they do have an impact rating fence.
