I understand that: The Beachwood Police Department will schedule a meeting with me to evaluate where to place barricades and how to ensure access by emergency vehicles. Emergency vehicle presence at the party depends upon availability & may need to depart in case of emergency. The applicant shall live on the street of the location of the block party. Items cannot be used for campaign events. If requesting supplies: I will submit a deposit check for \$150.00 to be applied toward any costs the City may incur to replace missing items or repair damage to any of the items, and if the cost to replace missing items or repair damaged items exceeds \$150.00, I agree also to pay the excess amount. I cannot reserve the trailer without this deposit, which will be refunded to me within 30 days after all items and the trailer key have been collected by the Public Works Department and no compensable damage is found. The Public Works Department will deliver a trailer with the barricades & supplies on the last business day before the party and will pick them up on the first business day after the party. I agree that all items will be returned in the same condition, reasonable wear and tear excepted. The trailer will be delivered to my address or across the street depending upon street-parking requirements. I shall be available to coordinate delivery and pick up of the trailer. Upon my receipt of the supplies, I will inspect them and if found not to be acceptable for use, inform the City by phone or email, and not use the item(s). THE UNDERSIGNED FURTHER AGREES THAT THEY WILL INDEMNIFY, DEFEND AND HOLD THE CITY, ITS OFFICERS, DIRECTORS, AGENTS AND EMPLOYEES HARMLESS FROM ANY AND ALL CLAIMS OR DEMANDS OF ANY KIND OR DESCRIPTION WHATSOEVER, INCLUDING WITHOUT LIMITATION, COSTS, AND REASONABLE ATTORNEY FEES ARISING FROM THE PROPOSED BLOCK PARTY.
