PUBLIC SERVICE ANNOUNCEMENT REGARDING PAYING YOUR PROPERTY TAX BILLS

The Cuyahoga County Treasurer's Office collects property taxes and we learned that some residents did not receive their statements in the mail. **The property tax deadline is being extended to Thursday, February 29, 2024, for payments covering either the 1st half or the whole year for Beachwood residents.** Residents should be receiving a letter from the county addressing this issue. If you want the bill resent to you, call 216-443-7400 and dial option 1 and listen for further options.

To pay your bill, you can follow one of these options:

Pay Online

**Please note: There is no fee for payments by electronic check. Fees apply when paying online using a debit or credit card. Debit cards are a flat fee of \$2.95 and credit cards are 2.3% with a minimum charge of \$1.50.*

Pay by Phone

Call 1-877-738-1212 to pay by debit/credit card or e-check. You must enter a Star/Asterisk within the parcel number. For example, for parcel number 123-45-678, you would enter the parcel number on the phone as 123*45*678.

**Please note: Fees apply when paying by phone using a debit or credit card. Debit cards are a flat fee of \$2.95 and credit cards are 2.3% with a minimum charge of \$1.50.*

Pay in Person

Visit the Treasurer's Office at **2079 East 9th Street, 1st Floor, Cleveland, OH 44115** to pay at the kiosk or in the Cashier's office. The kiosk takes checks and cash only. Cashiers accept check, money order, debit or credit card, and cash. Hours: M-F, 8:30 am – 4:30 pm.

Pay by Mail

If you have a copy of the bill, include the bottom portion with your payment and mail to:

Pay by Drop Box

Drop your payment (check, cashier's check or money order only. **DO NOT DROP CASH**) in the drop box outside the Cuyahoga County Administrative building, 2079 E 9th St, Cleveland, OH 44115



Other Ways to Pay

Key Bank will accept check or money order payments at Cuyahoga County branch locations. The customer must provide the original tax bill to process the payment over the counter.
